1.1 **Symbols**

3 Usage

3.1 Installing/Removing the Crutch/Cane Holder

Installing

- 1. Remove the cap (not shown) from the accessory tube located on the back of the seat.
- 2. Install the crutch/cane holder into the accessory tube.
- 3. Install the mounting knob to secure the crutch/cane holder in place. Securely tighten.

Removing

- I. Remove the mounting knob that secures the crutch/cane holder in place.
- 2. Remove the crutch/cane holder from the accessory tube.




FIGURE I Installing/Removing the Crutch/Cane Holder

4 Limited Warranty

This warranty is extended only to the original purchaser/user of our products.

Invacare warrants the crutch/cane holder to be free from defects in materials and workmanship for six months for the original purchaser. If within such warranty period any such product shall be proven to be defective, such product shall be repaired or replaced, at Invacare's option, with refurbished or new parts. This warranty does not include any labor or shipping charges incurred in replacement part installation or repair of any such product. Product repairs shall not extend this warranty - coverage for repaired product shall end when this limited warranty terminates. Invacare's sole obligation and your exclusive remedy under this warranty shall be limited to such repair and/or replacement.

For warranty service, please contact the dealer from whom you purchased your Invacare product. In the event you do not receive satisfactory warranty service, please write directly to Invacare at the address on the back page. Provide dealer's name, address, model number, date of purchase, indicate nature of the defect and, if the product is serialized, indicate the serial number.

Invacare Corporation will use a return authorization. The defective unit or parts must be returned for warranty inspection using the serial number, when applicable, as identification within thirty days of return authorization date. DO NOT return products to our factory without our prior consent. C.O.D. shipments will be refused; please prepay shipping charges.
