3 Usage


3.1 Using the Rear Basket



For this procedure, refer to FIGURE I.

Reverse STEPS I-3 to remove the rear basket.

- I. If necessary, loosen but DO NOT remove the mounting knob.
- 2. Install the rear basket into the accessory tube.
- 3. Install the mounting knob to secure the rear basekt to the accessory tube.



4 Limited Warranty
